The Fund aims to provide investors with above average capital growth over a medium to long term period by investing in a carefully selected portfolio of Shariah-Compliant Securities.





Based on the fund's portfolio returns as at 31st January 2025, the Volatility Factor (VF) for this fund is 11.14 and is classified as Moderate (source: FIMM as at 10st February 2025). Moderate includes funds with VF that are above 9.085 but not more than 12.01.
