Fund Objective


The Fund aims to provide investors with above average capital growth over a medium to long term period by investing in a carefully selected portfolio of Shariah-Compliant Securities.





Based on the fund's portfolio returns as at 30th September 2024, the Volatility Factor (VF) for this fund is 10.70 and is classified as Moderate (source: FIMM as at 10th October 2024). Moderate includes funds with VF that are above 9.025 but not more than 12.075.

The Volatility Class (VC) is assigned by FIMM based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months.
